RESULTS OF THE JULY, 2011 BAR EXAMINATION

There were 71 candidates for admission who sat for all or part of the bar examination held on July 26 & 27, 2011 in Montpelier, Vermont.

Forty-eight or 68% have succeeded in passing both the essay examination and the Multistate Bar Examination portions. Certain applicants had previously certified essay or MBE scores. These are only reflected in the overall pass rate.

Sixty-six candidates sat for the essay examination given on July 26. Fifty or 78% passed that examination portion.

Sixty candidates sat for the Multistate Bar Examination in Vermont, given on July 27. Forty-three or 72% passed that examination.
